On November 18, 2011, Northern New England Telephone Operations LLC d/b/a FairPoint Communications - NNE (FairPoint) filed a tariff revision for effect December 19, 2011, to its Premise Work Services.

Staff has requested a 30 day extension to complete its review of the proposed changes. According to Staff, it needs more time to review FairPoint's responses to Staff's questions regarding this matter.

Pursuant to RSA 378:6, IV, "The Commission may, in its discretion and with reasonable explanation, including an explanation of the likely areas of disagreement with the tariff, extend the time for its determination by up to 30 days."
