Enclosed for your review and approval is an initial aggregator's registration for Alternate Power Source Inc. along with the filing fee of \$250.00 in compliance with Puc 2003.4 (d).

Alternate Power Source Inc. is currently acting as a broker for two customers in New Hampshire but is not actively marketing in New Hampshire. The two customers are based in Massachusetts and requested APS to identify electric suppliers for them for their New Hampshire accounts. (APS is a registered broker in Massachusetts number EB-005)

APS does not believe it meets the definition of an aggregator in New Hampshire and maintains it is in compliance with Puc 2003.04 (a), (b). However, it is our understanding that the New Hampshire PUC considers brokers as aggregators. As such, we have enclosed our application and look forward to remedying any potential misunderstandings related to the definitions in Puc 2002 and APS's responsibility to register as an aggregator.






