The application filed by 186 Communications, LLC, (186 Communications) to provide CLEC service in the FairPoint and TDS territories of New Hampshire has been approved, as the accompanying certificate attests. 186 Communications' registration number is CL-02-001-12.

As a reminder, as 186 Communications conducts business as a CLEC, the Commission expects the company to comply with all applicable administrative rules and provide the highest level of customer service. In particular, the Commission requires yearly updates of the company's progress which you will provide by filing NH Puc Forms CLEC-1, CLEC-2, CLEC-3, CLEC-4, CLEC-5 and CLEC-40 by March 31st each year. Pursuant to Commission rules, the company must attain its first retail customer within two years of its certification date. At or before that time, 186 Communications must file with the Telecommunications Division NH Puc Form CLEC-12, *Initiation of Operations*. All CLEC forms are available at our web site: www.puc.nh.gov. The Commission also requires notification from 186 Communications of address changes, restructuring, acquisitions, or other major events as outlined in Commission rules.

186 Communications has not filed a proof of surety bond, and is therefore not authorized to collect customer deposits or bill in advance. The services that 186 Communications has listed in its application do not include local voice service. 186 Communications should report any local voice service offerings in New Hampshire to the Commission before requesting any telephone number blocks.
