Dear Mr. O'Brien:

On December 27, 2011, Risk Services Group, Inc. d/b/a RSG Energy (RSG) filed with the Commission an application for renewal of its registration as a natural gas aggregator, together with the renewal application fee of \$125.00; this filing was updated by a letter dated January 6, 2012.

Following its review of the filing, Commission Staff has determined that the renewal application for registration as a natural gas aggregator meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.05. On January 23, 2012, Staff filed its recommendation to approve the application. The Commission will approve the registration with an effective date of April 9, 2012, which coincides with the expiration of the existing registration for RSG. The renewal registration will expire at the end of business on April 7, 2017.

Additionally, please bear in mind that, pursuant to N.H. Code Admin. Rules Puc 3003.05 (a), each aggregator shall re-register with the Commission by filing an application for renewal at least 60 days prior to the expiration of its registration, i.e., in the case of RSG, on or before February 7, 2017. Please file a timely renewal application. Registration instructions and a checklist of requirements to properly file a renewal registration application are located on the Commission website at <http://www.puc.nh.gov/Gas-Steam/CNGS-Aggregator%20registration%20application%20instructions%20and%20checklist.pdf>.
