On February 10, 2012, Granite State Electric Company d/b/a National Grid (the "Company") plans to issue a Default Service Request for Proposals ("RFP") to procure default service for the period May 1, 2012 through and including July 31, 2012 for its Large Customer Group and the period May 1, 2012 through and including October 31, 2012 for its Small Customer Group. Pursuant to the terms of the Settlement Agreement approved by the Commission in Order No. 24,577 (January 13, 2006) in Docket No. DE 05-126 as modified by Order No. 24,922 (December 19, 2008) in Docket No. DE 08-011/DE 05-126 (the "Settlement Agreement"), the Company plans to solicit a bid price that includes the cost of all market products on an as-delivered energy basis and an all-inclusive bid price.

For notice purposes, I submit the Company's proposed timeline for the February RFP and the next successive RFP, which was provided as part of the Company's most recent default service filing in Docket No. DE 11-016.
