Please be advised that on May 31, 2013, the Commission found it impractical to extend the Tuesday, June 11, 2013 deadline for the submission of written comments regarding the initial proposal. Interested parties are encouraged to submit not only general comments but also specific wording changes to the initial proposal that implement their comments. The Commission has scheduled a technical session for Tuesday, June 18, 2013 commencing at 10:00 a.m. to allow interested parties to discuss the specific wording changes suggested by the parties and Staff. The Commission also decided that, if substantial changes are made to the initial proposal as a result of the Commission's consideration of comments, then the Commission staff will circulate a draft final proposal. If a draft final proposal is circulated, then the Commission will schedule further technical sessions and a hearing to receive comment on the draft final proposal.
