Dear Ms. Fehrman:

On February 3, 2012, TDS Telecommunications, Inc. submitted tariff filings to establish a process for identifying and rating VoIP/PSTN access traffic for its operating companies, Wilton Telephone Company, Hollis Telephone Company, Merrimack County Telephone Company and Kearsarge Telephone Company.

Staff reviewed the revisions, and by its memorandum dated February 6, 2012, recommended that the Commission extend the review period by up to an additional 30 days pursuant to RSA 378:6, IV. Staff's memorandum stated that the extension was necessary to afford sufficient time to determine whether the proposed revisions, particularly as relates to the default percentages, conform to the FCC's requirements.

The Commission has adopted Staff's recommendation and, pursuant to RSA 378:6, IV, extended the review period to allow up to 60 days to complete the investigation of the proposed revisions to these tariffs.
