Request for Additional Information

Dear Ms. Beebe:

On March 06, 2012, the New Hampshire Public Utilities Commission (Commission) received an application from SREC Generating Company, Inc. on behalf of the Steuben Landfill requesting certification for the electrical production from Steuben Landfill's methane gas burning generation facility as a Class I renewable energy source pursuant to RSA 362-F, New Hampshire's Renewable Portfolio Standard law. The Commission received response to this information request on April 06, 2012.

During continued review of the application staff has noted that an Interconnection Agreement has not been provided. Puc 2505.02 Application Requirements¹ (b)(8) states: *(...the application shall include) Proof that the applicant either has an approved interconnection study on file with the commission, is a party to a currently effective interconnection agreement, or is otherwise not required to undertake an interconnection study.*

I recognize that the interconnection agreement may be a very large document, and it may need to be a confidential document. I use the Interconnection Agreement to verify nameplate capacity and to prepare a very general description of how the generation facility is connected to the distribution utility. If you can provide the pertinent pages of

the Interconnection Agreement, that will suffice. If you need the Interconnection Agreement to remain confidential please follow the Adopted Final Rule 2011-113, Puc 100-Puc 200 Rules of Practice and Procedure (incl. Confidentiality) available at the PUC's home page.

Submission of the above information must be received by the Commission to complete your application. Until such time, it cannot be processed. If the requested information and documentation are not provided within ten business days of the date of this letter, your application will be denied without prejudice. Please refer to docket number **DE 12-059** in all future correspondence with the Commission.
