Karen,

I have been reviewing the March 26, 2012 tariff filings for the TDS companies in New Hampshire.

The provisions appear reasonable with one exception: the initial time window for the Customer to furnish an initial PVUC factor (2.3.11(C)(4)(a)).

The tariff is filed for effect on April 25, 2012, but the deadline for the initial Customer filing – which determines treatment of traffic for Dec. 29, 2011 through June 2012 - is April 15, 2012. That doesn't seem reasonable.

Would you consider revising this to provide a minimum window of 30 days following the tariff becoming effective – that is, changing the deadline to May 25, 2012 or later?
