

To the Parties:

On August 21, 2012, eleven independent New Hampshire incumbent local exchange carriers who are members of the New Hampshire Telephone Association (the "Eleven ILECs") petitioned the Commission for intervention in the above referenced matter. No objections to the intervention request have been filed.

The Order of Notice entered in this docket established May 21, 2012 as the date for filing petitions to intervene. However, the Eleven ILECs indicated in the petition a willingness to abide by the procedural schedule established for the docket.
