Notice of Intent to File Rate Schedules  
Motion for Waiver/Extension of Time

To the Parties:

On June 14, 2012, Aquarion Water Company (Aquarion) filed a motion to waive Puc 1203.02 (d) requiring notice to customers of an application for a general rate change no later than 30 days from the date of filing such application with the Commission. In its motion, Aquarion states that it is working with Commission staff to obtain approval of the proposed notice and requests additional time until July 1, 2012 to finalize the notice.

The Commission will treat Aquarion's motion to waive Puc 1203.02 (d) as, in effect, a request for an extension of time to provide notice to customers of its application for a general rate change. Pursuant to Puc 202.04, the Commission has determined that the extension will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, Aquarion's request has been granted.
