To the Parties:

On December 5, 2012, Staff and the parties filed a request to modify the procedural schedule in the above-referenced matter. The filing states that testimony is due on January 4, 2013, and requests that an additional week be added to prepare for testimony. Additionally, because the technical session scheduled for January 11, 2013 would coincide with the testimony due date, it should also be moved a week ahead.

The Commission has determined that the proposed modification is in the public interest and therefore has approved it. Accordingly, testimony is due on January 11, 2013, and the technical session has been rescheduled to January 18, 2013. The remainder of the schedule is unchanged.
