Dear Mr. Lackey:

On April 3, 2012, Sovernet Fiber Corp. d/b/a Vermont FiberConnect (FiberConnect) petitioned the Commission to amend its existing authority to offer competitive local exchange service authorized by CLEC certification No. CL-06-001-11, June 9, 2011. FiberConnect seeks to expand its authorization from those areas formerly served by Verizon Communications, to include the entire state of New Hampshire.

This request to expand the area of authorization has been approved, and is documented in the attached revised certificate: CLEC certification CL-06-001-11, now specifying the entire state.

As a reminder, as FiberConnect conducts business in New Hampshire, the Commission expects the company to comply with all applicable rules and provide the highest level of customer service. The filing requirements that FiberConnect has previously followed remain in effect, including requirements for annual reports due March 31st of each year.

The services that FiberConnect has listed in its application do not include local voice service. FiberConnect should report any local voice service offerings in New Hampshire to the Commission before requesting any telephone number blocks.
