

Dear Ms. Parker:

On May 14, 2012, Comcast Phone of New Hampshire, LLC (Comcast) submitted a letter to the Commission stating that its access rates are published on its web site as the "New Hampshire Access Service Guide" (ASG), and are already at interstate rates and therefore conform to the requirements of the Federal Communications Commission (FCC) in its order, *Connect America Fund et al.*, WC Docket No. 10-90 *et al.*, Report and Order and Further Notice of Proposed Rulemaking, 26 FCC Rcd 17663 (2011).

Staff reviewed the ASG rate schedule and confirmed that Comcast access rates conform to the FCC's requirements. The Commission has accepted Staff's assessment.

The ASG rate schedule does not appear to be on file with the Commission. Under N.H. Code Admin. R. Puc 431.06, a CLEC is to have a rate schedule on file with the Commission and under Puc 449.10 that rate schedule is to include information on each service offered. The services in the ASG appear to fit these definitions. Accordingly, Comcast shall file the information in the ASG with the Commission as a component of its rate schedule.
