Tariff Filing to Add Provisions for Toll VoIP-PSTN Traffic

Dear Mr. Stafford:

On May 15 2012, Granite State Communications submitted a filing to revise its NHPUC tariff so as to establish a process for identifying and rating VoIP / PSTN traffic. The proposed revision addresses new requirements established by the Federal Communications Commission (FCC) regarding VoIP traffic charges.

Staff reviewed this revision and concluded that it is consistent with FCC requirements and provides a reasonable process for identifying and rating the traffic involved, and recommended that the revision be allowed to take effect. The Commission has accepted Staff's recommendation. The tariff will go into effect by operation of law on June 14, 2012.

For administrative efficiency, an order will not be issued by the Commission either suspending, rejecting, or approving the proposed tariff changes. Pursuant to RSA 378:3 and RSA 378:6, IV, the proposed revision, as filed, and pursuant to Staff's recommendation, is effective as of June 14, 2012. Tariff pages should be filed referencing Docket No. DT 12-125 and reflecting the effective date of June 14, 2012.
