Re: DE 12-127, Residential Renewable Energy Generation Rebate Program
Notice of Funding Availability to Eliminate Waiting List

To Interested Parties:

By Secretarial Letter dated March 27, 2012, the Commission created a waiting list for residential renewable energy generation rebate applications to address a shortfall in program funding for state fiscal year 2012. In early July, the Commission's Renewable Energy Fund (REF) received a new round of funding for state fiscal year 2013.

The Commission has determined that there is now sufficient funding in the REF to eliminate the waiting list. Those already on the waiting list whose Step 1 applications have been deemed complete may proceed with construction, upon receipt of a letter from the Commission authorizing a rebate. Those whose Step 2 applications have already been approved by the Commission will now receive rebate payments. If you are uncertain regarding the status of your application, please contact Jon Osgood at 271-6306 or jon.osgood@puc.nh.gov.

New rebate applicants will no longer be placed on a waiting list. Rebate payments will be made on a first-come, first-served basis based on the date and time of receipt of completed Step 2 applications.
