Dear Ms. Chandler:

On June 5, 2012, MCI Metro Access Transmission Services LLC dba Verizon Access Transmission Services submitted proposed rate changes to revise its intrastate access rates to comply with the requirements of the Federal Communications Commission (FCC) in its order, *Connect America Fund et al.*, WC Docket No. 10-90 *et al.*, Report and Order and Further Notice of Proposed Rulemaking, 26 FCC Rcd 17663 (2011). The proposed revisions address the requirement that carriers reduce their intrastate access revenues.

Staff reviewed these revisions and concluded that they are consistent with the FCC's requirements. The Commission has accepted Staff's recommendation that the rates conform to the requirements of the FCC's order.

For administrative efficiency, an order will not be issued by the Commission suspending, rejecting, or approving the proposed changes and the proposed changes will take effect on July 1, 2012 as stated in the filing.
