On August 27, 2013, North American Power and Gas, LLC (North American Power), a competitive electric power supplier currently authorized to provide service in the franchise area of PSNH, filed a request to expand its service area to include the franchise areas of Liberty Utilities (Liberty) and Unitil Energy Systems (Unitil). With its filing, North American Power included copies of certificates demonstrating it had completed electronic data interface testing with Liberty and Unitil.

Staff reviewed the filing and recommended the Commission approve the request. The Commission, therefore, approves North American Power's request to expand its service area to include the franchise areas of Liberty and Unitil, effective on the date of this letter.
