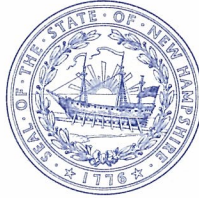

Re: DT 08-028, TDS Request for Authority to Block Global NAPs Traffic
Cancellation of Hearing

To the Parties:

On November 13, 2008, Global NAPs filed in the above referenced proceeding a cover letter and supplemental representation to support its request for confidential treatment of its 2005, 2006 and 2007 annual reports. Staff subsequently filed a recommendation that the Commission grant confidential treatment provided that parties to the docket have received copies of the annual reports under protective agreement, as Global NAPs asserts in its cover letter. Staff further recommended that, in lieu of holding a hearing on the confidentiality issue on November 14, 2008, parties be provided 5 days to comment on Global NAPs's filing and Staff's recommendation.

The Commission has accepted Staff's recommendation to treat Global NAPs's 2005, 2006 and 2007 annual reports as confidential pursuant to RSA 378:43, II. Accordingly, the hearing scheduled for November 14, 2008, pursuant to Commission Order No. 24,907 and the Commission's November 6, 2008 Secretarial letter, has been cancelled.

The Commission further directs parties who wish to submit comments on Global NAPs's filing to do so by November 21, 2008. Staff is directed to confirm by November 21, 2008, that all parties who requested proprietary copies of Global NAPs's 2005, 2006 and 2007 annual reports in Docket No. DT 08-028 have concluded protective agreements and received the requested copies.
