Re: Notice of Pending Disconnection

Dear Mr. Rooney:

This letter is formal notice of TDS Telecom subsidiaries or affiliates', Hollis Telephone Company, Inc., Kearsarge Telephone Company, Merrimack County Telephone Company (incl Contoocook Valley Telephone Company), Union Telephone Company and Wilton Telephone Company, Inc. (collectively, "TDS Telecom") intent to disconnect services to Global NAPs, Inc and its affiliates in the state of New Hampshire pursuant to New Hampshire Code of Administrative Rules PUC 412.19 and the New Hampshire Public Utility Commission's order in Docket DT 08-028 dated April 2, 2010 for violation of applicable tariff provisions, including non-payment for services rendered.

As discussed in the Commission's Order, disconnection shall mean "suspension or interruption of service" such that traffic identified as Global NAPs' traffic shall no longer be allowed to terminate on the network of TDS Telecom. **Disconnection of services to Global NAPs shall occur on or after May 4, 2010** unless payment is received in full for the charges incurred on the account numbers detailed below by May 3, 2010.
