Dear Ms. Howland:

Lakes Region Water Company, Inc. was directed by the Commission to file Record Requests 5, 6, and 9 no later than Friday, March 30, 2012. Pursuant to Commission rule Puc 203.02, Filing Requirements, "for a filing to be effective in an adjudicative proceeding, a party shall:

- (1) File one original and 6 paper copies of all documents with the commission...;
- (2) File an electronic copy, as required by Puc 203.03, with the commission; and
- (3) Serve pursuant to Puc 203.11 an electronic copy on each person identified on the commission's service list for that docket."
