Tariff Filing to Comply with FCC Intrastate Access Rate Order

Dear Ms. Walsh:

On July 2, 2012, Dixville Telephone Company (Dixville) submitted a tariff filing to revise its intrastate access rates in New Hampshire so as to comply with the November 18, 2011 Order of the Federal Communications Commission (FCC) setting caps on terminating intrastate access rates (FCC 11-161 and subsequent FCC revisions and clarifications).

Staff has reviewed historical data regarding intrastate and interstate access rates, intrastate traffic /service volumes, and associated access revenue levels provided by Dixville, as well as current access tariff terms for Dixville. In Staff's assessment, the rate structure and rates in the Dixville tariff filing comply with the FCC rules regarding intrastate access rates. Staff has recommended that this tariff filing be allowed to go into effect. The Commission has accepted Staff's recommendation. The tariff will go into effect by operation of law on July 3, 2012.

For administrative efficiency, an order will not be issued by the Commission either suspending, rejecting, or approving the proposed tariff changes. Pursuant to RSA 378:3 and RSA 378:6, IV, the proposed revision, as filed, and pursuant to Staff's recommendation, is effective as of July 3, 2012. Tariff pages should be filed referencing Docket No. DT 12-179 and reflecting the effective date of July 3, 2012.
