Dear Mr. Spillane:

By letter dated October 15, 2015, Glacial Natural Gas, Inc. (Glacial NG) filed a letter regarding its intent to relinquish its registration as a competitive natural gas supplier (CNGS). On October 30, 2015, Glacial NG confirmed that it had successfully transferred all eligible customers to Agera Energy LLC, a registered CNGS under Docket DM 14-299. Agera Energy LLC filed a separate letter confirming the transfer of all such eligible customers to its service. On November 10, 2015, Commission Staff filed a memorandum recommending that the Commission approve the termination of Glacial NG's CNGS registration.

The Commission's rules governing CNGS do not provide for the relinquishment, withdrawal, rescission, or abandonment of a CNGS registration. The Commission has reviewed your letter and has deemed it a request for waivers of N.H. Code Admin. Rules Puc 3003.01(f) (approved CNGS registration valid for five years), and Puc 3003.01(h) (registered CNGS to continue compliance with requirements of Puc 3000). The Commission has determined that the requested waivers, without any further conditions, are in the public interest and will not disrupt the orderly and efficient resolution of matters before the Commission, and that the purpose of the rules will be satisfied by the termination of Glacial NG's CNGS registration, effective as of the date hereof.

Accordingly, Glacial NG's competitive natural gas supplier registration is deemed withdrawn and terminated, effective as of the date of this letter.
