Re: DE 12- 210, Spaulding Ave Industrial Complex, LLC's Application for Additional Class I Eligibility for Renewable Energy Certificates (RECs) for the Spaulding Pond Hydroelectric Facility, Pursuant to RSA 362-F.

Dear Mr. Hickey:

On January 04, 2013, the PUC received a letter from Hydro Management requesting that we recognize RECs generated from electricity used behind the meter at the above referenced facility. According to the letter, this behind the meter generation asset is registered with the NEPOOL GIS under facility code NON35901.

On February 6, 2013, I received an email from you outlining the case for why the Commission should accept this generation as eligible for RECs under the New Hampshire Renewable Portfolio Standard, Chapter 362-F; this email was formalized in a letter received February 20, 2013. Staff has reviewed this letter and requests the following information:

- A completed, revised eligible facility application. (A hard copy of the application form is included with this letter. If you prefer an electronic copy, please contact me.)
- An engineering diagram of the facility's generation system, including how the generation unit is connected to the distribution utility.
- An explanation of how the complex is metered, including an explanation of the tenants' electricity accounts. Does each tenant have an individual retail account?
- Does the hydro facility displace all of the electricity needed by the tenants?
- Should this facility be regarded as both a customer-sited source as well as an end-user? Please elaborate.
- Explain which ISO-GIS rules you are relying on for this request, and how these rules apply to the Spaulding Pond facility.
