Good Energy, L.P. is requesting a waiver to the requirement that each aggregator file with the commission an application for renewal at least 60 days prior to the expiration of the currently effective registration. Good Energy was unaware of this new rule that was put in place after the approval of our initial application to provide electric aggregation service in New Hampshire. The approval letter stated that the Good Energy's original notice anniversary date is July 23, 2010 and therefore it is required to re-file an up-to-date written notice on or before July 23, 2012. As such, Good Energy, LP was operating under the assumption that this provision was still valid.


