The application for inCharge, LLC to register as a natural gas aggregator was received on August 7, 2012. Staff of the New Hampshire Public Utilities Commission (Commission) has completed its review of the registration application. The submitted application included incorrect information in one of its responses and is therefore deficient in its current form.

inCharge, LLC should update its response to the following requirement in its registration application:

Puc 3006.02(a)(6) - A list of the approved CNGSs through which your company may provide service.

Currently, five of the nine entities identified as CNGSs in the original application are not approved Competitive Natural Gas Suppliers in New Hampshire. Some of the entities listed in the application may be operating in New Hampshire as approved Competitive Electric Power Suppliers (CEPS) but operate under different CNGS trade names. Please refer to the approved list of CNGSs on the Commission web page at the following link: <http://www.puc.nh.gov/Gas-Steam/naturalgascompetition.htm>

In order to complete the registration process, inCharge, LLC will need to address the issue referenced above. This requirement should be administratively straight forward to correct. A letter with the updated information should be filed at your earliest convenience to the docket number assigned to this application (DM 12-249).
