RE: DT 12-260: Registration of 365 Wireless, LLC, as a Competitive Local Exchange Carrier (CLEC)

Dear Mr. Cash:

The application filed by 365 Wireless, LLC (365 Wireless) to provide CLEC service in New Hampshire has been approved, as the accompanying certificate attests. 365 Wireless' registration number is CL 01-002-13.

As we discussed, 365 Wireless intends to provide telephone service that appears to meet the definition of "Voice over Internet Protocol" (VoIP) service under New Hampshire law, and to also provide telephone service that uses non-IP technologies instead. As a result, 365 Wireless falls under two different regulatory standards in New Hampshire. VoIP services are not subject to regulation of market entry. Other telephone services that 365 Wireless intends to offer are not similarly exempted, and your application has therefore been approved with regard to the provision of those services.

As 365 Wireless conducts business in New Hampshire, the Commission expects the company to provide the highest level of customer service. The Commission requires yearly updates of the company's progress which you will provide by filing NH Puc Forms CLEC 1 through 5 and CLEC-40 by March 31st of each year. Upon attaining its first retail non-VoIP customer, 365 Wireless must file with the Telecommunications Division NH Puc Form CLEC-12, *Initiation of Operations*. All such CLEC forms are available at our web site: www.puc.nh.gov. The Commission also requires notification from 365 Wireless of address changes, and of restructuring, acquisitions, or other major events regarding provision of non-VoIP services as outlined in Commission rules.

Although changes in New Hampshire telecommunications law became effective on August 10, 2012, revised forms will not be available until the Commission amends its rules. This rulemaking process will not be completed until late 2013.
