On May 30, 2013, you filed on behalf of Granite State Electric Company d/b/a Liberty Utilities (Liberty) a request for an extension until June 21, 2013 to file the shareholder incentive calculation for the Company's CORE electric programs due June 1, 2013. You state in your request that Liberty needs additional time to complete the calculation inasmuch as it involves a reconciliation of records between National Grid for the first half of the program year in 2012 and Liberty for the remainder of the year.
