Dear Mr. McCrillis:

On September 12, 2012, the PUC received an application requesting that the REM Partnership photovoltaic facility be granted eligibility for Class II RECs pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard (RPS) law. Staff has reviewed the application and all submitted information and recommends approval noting the application was completed September 12, 2012.

Class II eligibility requires a facility to produce electricity from solar technologies and to have initiated operation after January 1, 2006. The application indicates that the REM Partnership installation, located at 2 North Main Street, Newport, NH, began operation on May 23, 2012. Pursuant to Puc 2502.13, REM Partnership is a customer-sited photovoltaic facility; therefore, its output is not recorded in the NEPOOL Market Settlement System and must be monitored and verified by an independent monitor. The application states that Paul Button, Energy Audits Unlimited, will serve as the facility's independent monitor as required by the New Hampshire Code of Administrative Rules Puc 2505.08(b)(5). The nameplate capacity of the system is .0228 megawatt of electrical production.


The facility's New England Power Pool (NEPOOL) Generation Information System account number is NON 34380. The New Hampshire single certification code for the REM Partnership photovoltaic facility is NH-II-12-059.



Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified the REM Partnership photovoltaic facility as a Class II renewable energy source effective September 12, 2012. Accordingly, the REM Partnership photovoltaic facility is eligible to be issued New Hampshire Class II renewable energy certificates.

The REM Partnership photovoltaic facility is a .0228 megawatt customer-sited photovoltaic array; it began operation on May 23, 2012. The facility's independent monitor, Paul Button, Energy Audits Unlimited, will verify and report the electrical production to the New England Power Pool Generation Information System (NEPOOL GIS) as required by the New Hampshire Code of Administrative Rules Puc 2505.08(b)(5). The applicant's NEPOOL GIS account number is NON 34380. The facility's New Hampshire certification code is NH-II-12-059.
