2013 Stranded Cost Recovery Charge Rate Change

Dear Director Howland:

Enclosed please find an original and six copies of the updated Technical Statement and attachments of Michael L. Shelnitz setting forth Public Service Company of New Hampshire's ("PSNH") request for an adjustment to the current average Stranded Cost Recovery Charge ("SCRC") rate for effect July 1, 2013. This filing updates the Company's SCRC filing of May 2, 2013 and proposes an average rate of 0.272 cents per kWh, a decrease from the average rate of 0.385 cents per kWh proposed on May 2, 2013. PSNH is proposing the SCRC rate change to take effect July 1, 2013, coincident with its proposal to change the Energy Service rate.
