In compliance with the Commission's Order No. 25,626 dated January 31, 2014 in Docket No. DE 12-295 (PNE Energy Supply, LLC d/b/a Power New England, Review of Public Service Company of New Hampshire Tariff Charges to Competitive Energy Suppliers), the following tariff pages are transmitted herewith:

In its Order No. 25,626, the Commission approved the following temporary rates for the charges to Competitive Energy Suppliers, effective February 1, 2014:

1. The Selection Charge will change from \$5.00 to \$0.15 per transaction and will be charged consistent with Order No. 25,603;
2. The Billing and Payment Service Charge will change from \$0.50 to \$0.26 per bill rendered; and
3. The Collection Services Charge will remain at 0.252% of total monthly receivable dollars.

Once the Commission establishes permanent rates, permanent and temporary rates will be reconciled back to February 1, 2014. Rule Puc 1603.08(a)(4) requires the filing of a tariff supplement to establish a temporary modification of an existing tariff. Therefore, the temporary rates have been incorporated into Supplement No. 1 to Tariff NHPUC No. 8.


