Dear Ms. Howland:

Pursuant to the approved procedural schedule in the above-captioned docket, a merits hearing is scheduled for June 19, 2014.

The parties have agreed upon the issue in this docket—the amount of Public Service Company of New Hampshire (PSNH) charges competitive energy power suppliers (CEPS) for customer selection, billing and payment, and collection charges—and have agreed to forego any further discovery or testimony. The rates agreed to by the parties are as follows: no charge for customer selection, no charge for collections, and \$0.07 per month for billing and payment services. The parties do not intend to reduce the agreement to writing, but intend to proceed with a hearing based upon this agreement. The parties have not reached agreement on PSNH's proposal for supplier default selection charges in the event of a supplier default, but have agreed to present their arguments on that issue to the Commission at the hearing in this matter.

In addition the parties have agreed to reschedule the hearing date from June 19, 2014 to May 22, 2014. The Commission set temporary rates for the above charges in Order No. 25,626 (January 31, 2014) and holding the hearing on an earlier date will advance the reconciliation of the temporary rate with the proposed rate.

Susan W. Chamberlin, Esq., the Consumer Advocate, has indicated that she is not available on May 22, 2014; however, Attorney Chamberlin has stated that she is willing

to provide a letter to indicate the support of the Office of Consumer Advocate for the charges agreed to by the parties.

Based on the foregoing, Staff respectfully requests that the hearing be rescheduled from June 19, 2014 to May 22, 2014 to expedite the conclusion of this docket.
