On October 25, 2012, Vermont Public Power Supply Authority (VPPSA) submitted an application seeking certification for VPPSA to serve as an independent monitor for owners of customer-sited sources in its service territory in Vermont that qualify for New Hampshire renewable energy certificates (RECs), pursuant to N. H. Code of Administrative Rules Puc 2505.09.

Staff has reviewed the application and believes it meets the requirements for certification inasmuch as VPPSA is currently certified as an independent monitor under both the Commonwealth of Massachusetts and the State of Maine renewable portfolio standard programs.
