On June 12, 2013, Staff, FairPoint and the CLEC Association of Northern New England, Inc. (CANNE) filed a request to extend by two weeks the deadline for submission of briefs in the above referenced matter. According to the request, the parties in attendance at the June 5, 2013 technical session indicated some of the issues were narrowed and that a settlement may be reached in this docket. Staff notes that it will proceed with discovery of the non-CANNE member CLECs to further narrow the issues.

The Commission has determined that the extension will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, the request has been granted. Briefs are due by June 28, 2013.
