To the Parties:

On July 25, 2013, Commission Staff filed a memorandum in the above-referenced proceeding summarizing the current status of its investigation of the alleged fiber-based collocations in wire centers listed in FairPoint's revised NH PUC Tariff No. 2. In this memorandum, Staff described the need for a second round of discovery requests and recommended that the Commission extend the due date for Staff's investigation report until August 12, 2013.

The Commission has determined that the requested extension will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, the request has been granted. Staff's wire center investigation report is due no later than August 12, 2013.
