Dear Ms. Knowlton:

On March 5, 2014, the Commission suspended by secretarial letter the portion of Order No. 25,625 that required Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty Utilities (Liberty) to file its next Least Cost Integrated Resource Plan by December 1, 2014. As delineated in the March 5, 2014 secretarial letter, and in light of the passage of HB 1540 on June 16, 2014, the Commission has determined to fix the due date of the Company's next LCIRP filing as January 15, 2016. This is in conformity with the language of HB 1540, which requires subsequent LCIRP filings to be made "within 2 years of the commission's final order regarding the utility's prior plan," as the final order accepting the Company's current LCIRP was issued on January 27, 2014.
