Affiliate Agreements

Dear Mr. Bisbee:

On January 2, 2013, Rosebrook Water Company, Inc. (Rosebrook) filed pursuant to the terms of RSA 366 affiliate agreements with BW Club, LLC (BW Club); BW Services, LLC (BW Services); MWH Construction Company, LLC (MWH); and Resort Waste Management (Resort Waste). Rosebrook also filed a contract for construction services with MWH related to a pump station generator. In addition, Rosebrook filed copies of invoices for services provided to Rosebrook by MWH. Rosebrook's filing acknowledges that the filing of these agreements and contracts is not timely in accordance with the requirements of RSA 366.

On January 23, 2013, Commission Staff filed a letter recommending that the Commission accept the filing of these agreements and close this docket. Staff noted that the agreements with BW Club, BW Services, and MWH are no longer in force as Rosebrook has directly hired four employees who provided the services previously under the affiliate agreements. Staff further indicated that Rosebrook's agreement with Resort Waste, effective January 1, 2013, provides that Rosebrook will provide management, accounting, and customer relations services to Resort Waste. Staff expressed concern that most of Rosebrook's operational and management costs in its current rate proceeding, Docket No. DW 12-306, arises from the now-defunct affiliate agreements, but that Staff intends to address those issues in that rate case. Staff noted that a prehearing conference in DW 12-306 is scheduled for January 29, 2013.

This letter serves as an acknowledgement that Rosebrook, pursuant to the requirements of RSA 366:3, has filed contracts between a public utility and an affiliate for the provision of services in exchange for compensation that exceeds \$500. This acknowledgement does not constitute approval of any rate or revenue requirement change that may be claimed as a result of the service provided for in the filed documents. As issues arising under the filed agreements can be

addressed in Rosebrook's current rate proceeding DW 12-306, the Commission will not open a separate investigation at this time under RSA 366:5. The Commission will accept the contracts as filed and will close this docket. Any further modifications of affiliate contracts must be filed with the Commission pursuant to RSA 366:3.
