2013 Default Service Solicitations

ORDER OF NOTICE

On January 22, 2013, Granite State Electric Company d/b/a Liberty Utilities (Liberty Utilities) filed a letter providing a partial schedule for its default service solicitations for 2013. Liberty Utilities will release its first request for proposal (RFP) on February 8, 2013 to procure default service for the period beginning May 1, 2013. Liberty Utilities makes its default service filings pursuant to the terms of a Settlement Agreement approved by the Commission in Order No. 24,577 (January 13, 2006) 91 NH PUC 6 as modified by Order No. 24,922 (December 19, 2008) 93 NH PUC 600.

Pursuant to the Settlement Agreement, Liberty Utilities solicits default service supply for its Large Customer Group every three months for 100 percent of a three-month block of power supply. Liberty Utilities then develops rates for the Large Customer Group based on the winning bid contract prices, with fixed monthly prices that vary from month to month. For its Small Customer Group, Liberty Utilities solicits prices for 100 percent of a six-month block of power supply and sets a fixed rate for the six-month period using a six-month weighted average. With the February 8, 2013 RFP, Liberty Utilities will solicit a three-month power supply contract for its Large Customer Group and a six-month supply for its Small Customer Group for the period beginning May 1, 2013.

As stated above, Liberty Utilities issues an RFP each quarter to procure default service supply for its Large Customer Group and every six months for its Small Customer Group. The approximate schedule for public hearings on the issuances, including the February 8, 2013 RFP, follows:

March 2013	RFP for three months of supply for the Large Customer Group (May through July, 2013); and six months of supply for the Small Customer Group (May through October 2013)
June 2013	RFP for three months of supply for the Large Customer Group (August through October 2013)
September 2013	RFP for three months of supply for the Large Customer Group (November 2013 through January 2014); and six months of supply for the Small Customer Group (November 2013 through April 2014)
December 2013	RFP for three months of supply for the Large Customer Group (February 2014 through April 2014).

The Commission designated Docket No. DE 13-018 as the docket number for all of Liberty Utilities' 2013 solicitations. The petition and subsequent docket filings, other than any information for which confidential treatment is requested of or granted by the Commission, will be posted to the Commission's website at <http://www.puc.nh.gov/Regulatory/Docketbk/2013/13-018.html>.

The filing raises, inter alia, issues related to whether the rates resulting from Liberty Utilities solicitation of default service supply are just and reasonable as required by RSA 378:5 and 7; and whether Liberty Utilities has procured default service consistent with the principles of the electric utility restructuring statute (RSA 374-F:3(V)(c)-(e) and Commission Orders No. 24,577 and 24,922. Each party has the right to have an attorney represent the party at the party's own expense.

Based upon the foregoing, it is hereby


ORDERED, that Hearing be held before the Commission located at 21 S. Fruit St., Suite 10, Concord, New Hampshire on March 19, 2013, at 10:00 a.m., as set forth in N.H. Code Admin. Rules Puc 203.15; and it is

FURTHER ORDERED, that pursuant to N.H. Code Admin. Rules Puc 203.12, Liberty Utilities shall notify all persons desiring to be heard at this hearing by publishing a copy of this Order of Notice no later than February 12, 2013, in a newspaper with general circulation in those portions of the state in which operations are conducted, publication to be documented by affidavit filed with the Commission on or before March 14, 2013; and it is

FURTHER ORDERED, that pursuant to N.H. Code Admin. Rules Puc 203.17, any party seeking to intervene in the proceeding shall submit to the Commission seven copies of a Petition to Intervene with copies sent to Liberty Utilities and the Office of the Consumer Advocate on or before March 14, 2013, such Petition stating the facts demonstrating how its rights, duties, privileges, immunities or other substantial interest may be affected by the proceeding, as required by N.H. Code Admin. Rule Puc 203.17 and RSA 541-A:32,I(b); and it is

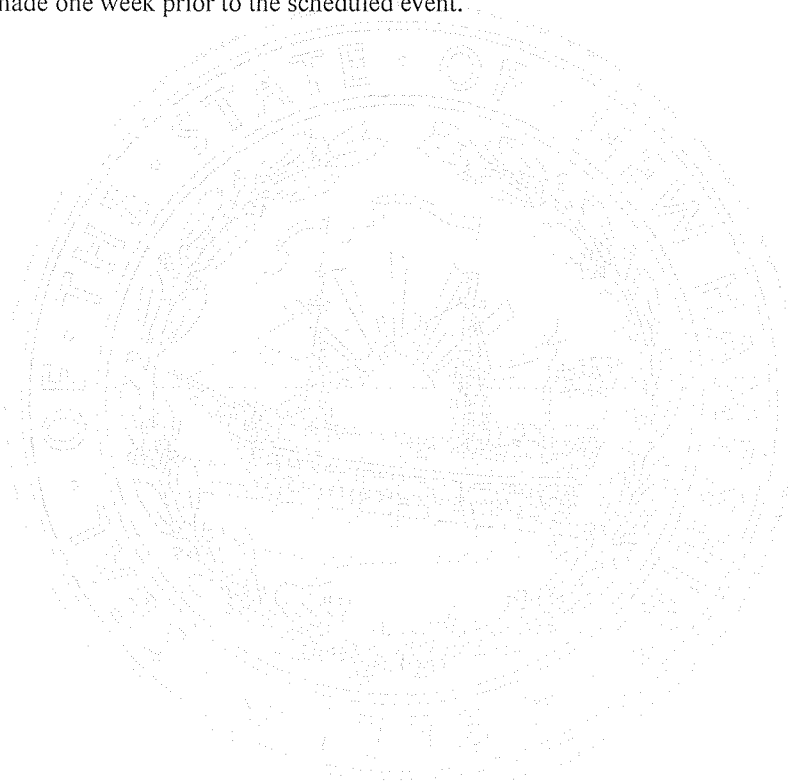
FURTHER ORDERED, that any party objecting to a Petition to Intervene make said Objection on or before March 19, 2013.
