On January 18, 2013, the New Hampshire Public Utilities Commission (Commission) received an application from Kheops International, Inc. (Kheops International) for Class II REC certification of the photovoltaic array at 232 US Route #3, Colebrook, NH, as a renewable energy source pursuant to RSA 362-F, New Hampshire's Renewable Portfolio Standard law.

On February 22, 2013 Staff sent a letter to Kheops International requesting a cover letter provided with an original and two copies as required on the Commission website.¹ Since that time, Staff has tried to reach you via email and phone and has received no response. As a result, the Commission hereby closes Docket No. DE 13-019 without prejudice.
