### *Summary*

On March 14, 2013, Solar Farm Bank LLC (Solar Farm Bank) submitted applications on behalf of New Hampshire entities REM – Linda Rice (REM), and David Strange requesting the Commission grant approval of photovoltaic (PV) arrays to produce Class II, Renewable Energy Certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law.<sup>1</sup> Solar Farm Bank intends to aggregate the RECs produced by these facilities. The Commission approved Solar Farm Bank as an aggregator of RECs on February 05, 2013.<sup>2</sup>

The Commission, in a non-adjudicative process, is required to issue a determination of whether a facility meets a particular classification within 45 days of receipt of a completed application. The REM array was previously approved for RECs on October 08, 2012; their request to transfer their account to the Solar Farm Bank aggregation was received March 27, 2013 and approved by the Commission on April 09, 2013. Solar Farm Bank is now requesting the REM and David Strange facilities be included in their Class II aggregation.

Both the REM and the David Strange facilities are customer-sited sources and meet the Class II eligibility requirements under RSA 362-F:4, II. Based on review of the applications, Staff recommends that the Commission approve the REM facility in the Solar Farm Bank Class II aggregation effective March 27, 2013, the day the Commission received REM's request to transfer their account to the Solar Farm Bank aggregation, thus completing the application. Staff recommends the Commission approve the David Strange facility in the Solar Farm Bank Class II aggregation effective March 14, 2013, the date Staff was able to determine the application was complete.

**Analysis**

To qualify as a facility eligible to produce RECs, Puc 2505.08 (b) requires the source to provide the following:

5. *The name and contact information of the independent monitor of the source.*

These facilities are customer-sited sources and their output must be monitored and verified by an independent monitor pursuant to Puc 2509.09. Paul Button is identified as the independent monitor for both facilities.<sup>3</sup> In addition to reporting each source’s output to the Commission, Mr. Button will include the total output of these facilities in the Class II totals reported to the NEPOOL Generation Information System pursuant to Puc 2505.09(h)(3).

6. *A copy of the interconnection agreement pursuant to PUC 307.06, if applicable, between the applicant and the distribution utility.* Copies of the interconnection agreements were provided.

7. *An attestation by the applicant that the project is installed and operating in conformance with any applicable building codes.* Attestations, signed by Stephen Hirsh were provided for both the REM Partnership and David Strange.
8. *For an installation with electric output, documentation of the applicable distribution utility’s approval of the installation.* A copy of the Certificate for Simplified Process Interconnection between each of the applicants and Public Service Company of New Hampshire was provided and includes the date of electrical inspection required for the utility’s approval of the installation.

RSA 362-F:6 requires the renewable portfolio standard program to utilize the regional generation information system (GIS) of energy certificates administered by ISO-New England. The GIS facility code assigned to the Solar Farm Bank aggregation is NON 35889.

**Recommendation**

Staff has reviewed Solar Farm Bank’s applications for the photovoltaic arrays located at the above-named facilities and can affirm both are complete pursuant to Puc 2505.08. Staff recommends that the Commission certify the REM Partnership PV array as being eligible for Class II RECs effective March 27, 2013, the day the Commission received REM’s request to transfer their account to the Solar Farm Bank aggregation. Staff recommends approval for the David Strange PV array as an eligible Class II facility effective March 14, 2013, the date Staff was able to make a determination that the facility meets the requirements for certification as a Class II renewable energy source. In addition, Staff recommends approval for the Solar Farm Bank to include both the REM and David Strange facilities in its Class II aggregation.
