**RE: DG 13-085 EnergyNorth Natural Gas, Inc.
 2013 Summer Period Cost of Gas – June 2013 Trigger**

Dear Ms. Howland:

On behalf of EnergyNorth Natural Gas, Inc. d/b/a Liberty Utilities (the “Company”) and in accordance with New Hampshire Public Utilities Commission Order No. 25,501, dated April 29, 2013 in Docket DG 13-085, I enclose an original and two copies of tariff pages and accompanying calculations setting forth the Company’s adjusted 2013 Summer Cost of Gas rates to be effective June 1, 2013. These adjusted rates require no further Commission action because they are within the maximum rates set forth in Order No. 25,501.

The adjusted cost of gas rates are being filed to reflect an update of the summer period deferred gas cost balance and the projected commodity prices for the remainder of the summer period, including optimizing the dispatch of supply volumes based on revised pricing. The attached estimated cost of gas was calculated using the 15-day average NYMEX settled prices as of May 17, 2013. The adjustments to the cost of gas rates are summarized in the following table.

The enclosed calculation page indicates that absent the adjustment, there would be an estimated under collection of gas costs as of October 31, 2013 of approximately \$541,696 or 4.21%.
