New Hampshire Code of Administrative Rules PART Puc 300, Rules for Electric Service

ORDER OF NOTICE

On September 9, 2013, the Commission voted pursuant to RSA 541-A to initiate a rulemaking for N. H. Code Admin. Rules PART Puc 300, Rules for Electric Service. The Commission's Initial Proposal represents a readoption of the existing Puc 300 rules with amendments.

The Puc 300 rules contain requirements for the provision of electric service in New Hampshire. The rules regulate meter testing and reading, service quality including voltage variation and interruption of service, notice to the commission of accidents and outages, and the requirement that utilities submit periodic reports for commission review. There are amendments to the rules. Principally, the amendments concern an improved definition of the criteria regarding master-metering, additional accident and reliability reporting requirements, a new requirement that utilities prepare and file emergency response plans, tree trimming standards and reporting related to wide scale outages. In addition, the rules related to bulk power supply facilities have been deleted as the bulk power supply statute was repealed since the last adoption of the Puc 300 rules. Upon conclusion of the formal rulmaking process, the proposed amended rule will replace the current version of Puc 300.

A rulemaking notice form (Notice), as required by RSA 541-A:6, was filed with the Office of Legislative Services on September 20, 2013 and has been sent to all regulated electric utilities.

The Notice establishes a public hearing to be held at the Commission on November 6, 2013 at 10:00 a.m. and a deadline for submission of written comments on November 13, 2013. That Notice is appended hereto. Pursuant to RSA 541-A:6, III, this Order of Notice will also be provided by public notice advertisement in a publication of daily statewide circulation.

Following the public comment hearing on November 6, 2013, Staff will hold a technical session with interested parties for purposes of discussing the proposed amended rule.

The readoption with amendment Initial Proposal may be viewed on the Commission website, <u>http://www.puc.nh.gov/Regulatory/Docketbk/2013/13-090.html</u>, or copies may be obtained from the Commission as set forth in the Notice.

Based upon the foregoing, it is hereby

ORDERED, that a Public Hearing, pursuant to 541-A:11, be held before the Commission located at 21 South Fruit Street, Suite 10, Concord, New Hampshire on November 6, 2013 at 10:00 a.m. followed by a technical session, and that the deadline for submission of materials in writing or via e-mail shall be November 13, 2013, as set forth in the Notice; and it is

FURTHER ORDERED, that pursuant to RSA 541-A:6, III, the Commission shall undertake a public notice advertisement by publishing a copy of this Order together with the Notice no later than October 9, 2013, in a newspaper with a daily statewide circulation, publication to be documented by affidavit filed with the Commission on or before November 1, 2013. 6. (a) Summary of what the rule says and the effect of the rule on those regulated:

The Puc 300 rules contain requirements for the provision of electric service to New Hampshire. The rules regulate meter testing and reading, service quality including voltage variation and interruption of service, notice to the commission of accidents and outages, and the requirement that utilities submit periodic reports for commission review. There are amendments to the rules. Principally, the amendments concern an improved definition of the criteria regarding master-metering, additional accident and reliability reporting requirements, a new requirement that utilities prepare and file emergency response plans, tree trimming standards and reporting related to wide scale outages. In addition, the rules related to bulk power supply facilities have been deleted as the bulk power supply statute was repealed since the last adoption of the Puc 300 rules.

The existing rules are scheduled to expire October 18, 2013 but are subject to extension pursuant to RSA 541-A:14-a.

6. (b) Brief description of the groups affected:

Those affected by the rules are the three electric distribution utilities in the state (Public Service Company of New Hampshire, Granite State Electric Company d/b/a Liberty Utilities and Unitil Energy Systems, Inc.). Puc 301.01(b) indicates the provisions of the rules that apply to the New Hampshire Electric Cooperative.
