Dear Mr. Harwell:

On April 25, 2014, you filed on behalf of Hess Energy Marketing, LLC (Hess Energy), a request to replace the surety bond dated April 12, 2013 and filed with the Commission on May 8, 2013, with a surety bond dated April 10, 2014. Like the April 12, 2013 surety bond, the April 10, 2014 surety bond is in the amount of \$350,000, has a term that expires on April 12, 2019, and names the Commission as obligee. In addition, the terms and conditions of the April 10, 2014 surety bond are nearly identical to those of the April 12, 2013 surety bond.
