





Applicant hereby submits updated information, including resumes of key technical staff, as evidence of HPG's technical ability to provide aggregator services to its members. As indicated by the resumes below, HPG's technical staff possesses a combined total of approximately 100 years in the energy/healthcare industry. As further evidence of HPG's experience and technical expertise, Applicant notes that since its inception in 1999, its membership has grown to more than 4,000 healthcare providers located in virtually every state, with an aggregate annual purchasing volume of over \$19 billion. Applicant currently procures natural gas for over 425 hospitals located in about 35 states, managing gas volumes of over 12 billion cubic feet annually.
