**Deficiency Letter** 

Dear Mr. Schiff:



The application for Ultimate Energy Advisors to register as a natural gas aggregator was received on April 26, 2013. Staff of the New Hampshire Public Utilities Commission (Commission) has completed its review of the registration application and notes one missing attachment (the secretary of state's authorization to do business in the State of New Hampshire) and one discrepancy where the applicant incorrectly listed a regulated LDC (Liberty Utilities) as a Competitive Natural Gas Supplier. As filed, the updated application is incomplete and is therefore deficient in its current form.

Ultimate Energy Advisors should address the following Commission requirements as appropriate in either its cover letter and/or in an update to its registration application:

- Puc 3006.02(a)(5) A copy of the applicant's authorization to do business in New Hampshire form the secretary of state, if anything other than an individual;
- Puc 3006.02(a)(6) A list of CNGSs in New Hampshire for which the applicant intends to provide service.

In order to complete the registration process, Ultimate Energy Advisors will need to address the issues referenced above. The requirements should be administratively straightforward to correct. A letter with the updated information should be filed in an expedient manner to the docket number assigned to this application (DM 13-124). Until such time that these issues have been resolved, the 60-day review period will be suspended.
