On behalf of Granite State Electric Company, Inc. d/b/a Liberty Utilities, I enclose for filing the affidavit of publication demonstrating that the Order of Notice in the above-captioned docket was published in the Eagle Tribune on June 3, 2013. The Eagle Tribune is a paper in general circulation in the Salem, New Hampshire area.

We were notified today by the Valley News that the newspaper failed to publish the Order of Notice on June 2 as it had agreed to do.
