
As directed by the Commission's Order *Nisi* No. 25,604 in the matter captioned above, the enclosed affidavit is filed with the Commission.

GRANTING LICENSE  
December 17, 2013

On May 28, 2013, Sovernet Fi-  
ber Corp. (Sovernet) filed a  
petition pursuant to RSA  
371:17 requesting a license to  
construct and maintain fiber  
optic communications cables  
over and across the public  
waters of the Mascoma River  
in Lebanon, New Hampshire  
parallel to the north side of  
Bank Street Extension. On  
October 25, 2013 and Novem-  
ber 18, 2013, Sovernet filed  
revised schematics regard-  
ing the proposed crossing in re-  
sponse to issues raised by  
Staff. According to the peti-  
tion, the proposed crossing  
will be placed between exist-  
ing utility poles in an existing  
public right-of-way.

### 1000 LEGALS
