

On May 29, 2013, Intelligen Resources LP (Intelligen Resource) filed an application with the Commission to register as a provider of electric aggregation service. On September 3, 2013, Intelligen Resources submitted additional information required for its application. Staff reviewed the application and determined that it is complete.

The Commission approves your application to register as a provider of electric aggregation service, effective September 17, 2013. The registration is for a term of 2 years and expires at the end of business on September 16, 2015. Pursuant to N.H. Code Admin. Rule Puc 2003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before July 18, 2015.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin.
