Dear Mr. Davis:

On June 11, 2013, Planet Green LLC (Planet Green) submitted an application with the Commission to register as a competitive electric power supplier (CEPS). Staff of the Commission has reviewed your filing and found issues that make your application incomplete. The following are issues Staff identified and the related N.H. Code of Admin. Rule requirement that must be met in order for your application to be complete.

- 1) Proof of EDI testing with each distribution utility with which Planet Green intends to do business.

*Puc 2003.01(d)(1) Demonstration of technical ability to provide for the efficient and reliable transfer of data and electronic information between utilities and the CEPS in the form of:*

*(a) A statement from each utility with which the CEPS intends to do business indicating that the applicant has complied with the training and testing requirements for electronic data interchange.*

*(c) A statement from each utility with which the CEPS does or intends to do business indicating that the applicant has successfully demonstrated electronic transaction capability.*

- 2) Proof that Planet Green is able to obtain supply in the New England energy market.

*Puc 2003.01(d)(2) Evidence that the CEPS is able to obtain supply in the New*


*England energy market. Such evidence may include, but is not limited to, proof of membership in the New England Power Pool (NEPOOL) or any successor organization, or documentation of a contractual relationship with a NEPOOL member.*

3) Proof of financial surety.

*Puc 2003.01(d)(4) Evidence of financial surety, as defined in Puc 2003.03.*

In order to complete your application you should respond accordingly to each of the items listed above. When responding, address your letter to Debra Howland, Executive Director, and reference the docket number listed on the subject line of this letter.
