Dear Mr. Herbest:

On June 17, 2013, Abest Power & Gas of NH, LLC (Abest) submitted an application with the Commission to register as a competitive electric power supplier. Staff of the Commission reviewed your filing and found issues which make the application incomplete. The following are issues Staff identified and the N.H. Code of Admin. Rule requirement that must be met in order for your application to be complete.

- 1) Proof of EDI testing with each distribution utility with which Abest intends to do business.

*Puc 2003.01(d)(1) Demonstration of technical ability to provide for the efficient and reliable transfer of data and electronic information between utilities and the CEPS in the form of:*

*(a) A statement from each utility with which the CEPS intends to do business indicating that the applicant has complied with the training and testing requirements for electronic data interchange.*

*(c) A statement from each utility with which the CEPS does or intends to do business indicating that the applicant has successfully demonstrated electronic transaction capability.*

- 2) Proof of financial surety.

*Puc 2003.01(d)(4) Evidence of financial surety, as defined in Puc 2003.03.*

- 3) Certificate from the Secretary of State showing that the applicant is authorized to do business in New Hampshire is missing.


*Puc 2006.01(9) A copy of the applicant's authorization to do business in New Hampshire from the secretary of state, if anything other than an individual.*

- 4) Signature.

*Puc 2006.01(22) The signature of the applicant or its representative.*

To complete your application you should respond to the issue listed above. When responding, address your letter to Debra Howland, Executive Director, and reference the docket number listed on the subject line of this letter.
